- Includes (i) 4,630 RSUs originally granted on January 4, 2022 that vest in equal monthly installments through January 1, 2026, (ii) 86,806 RSUs originally granted on January 1, 2023 that vest in equal monthly installments through January 1, 2027 and (iii) 68,167 RSUs originally granted on March 13, 2024 that vest in equal monthly installments through January 1, 2028. Each RSU represents the right to receive one share of Class A Common Stock upon settlement.
