- 2. **Fees**. We will charge you in advance for any zoom meetings in which you wish to participate, and all fees will be collected via our third party payment processor, Stripe. You may continue to purchase additional zoom meeting time as you may wish, unless and until your account is suspended or terminated pursuant to these terms, or the Exodus Support+ Program is suspended or terminated.
- 2.1. By choosing your debit or credit card as your primary payment method, you authorize Exodus to charge that card for any zoom meeting time you purchase, including applicable taxes in U.S. dollars.
- 2.2. We reserve the right to change the terms of the Exodus Support+ Program, including the fees, from time to time.
- 2.3 All fees are non-refundable. If you fail to attend any scheduled zoom meetings, our team will make a good faith effort to reschedule the meeting one time, but if we are unable to reschedule the meeting, or you fail to attend a scheduled zoom meeting more than one time, you will not receive a refund for any portion of the Fees you have paid.
- 2.5.
